

- 1. MIRU workover rig and associated equipment; NU and test BOP.
- 2. TOOH with tubing.
- 3. TIH with mill and tag CIBP over Dakota at 5,103'
- 4. Mill out isolation plug. Cleanout to PBTD at 7,050'. TOOH with cleanout assembly.
- 5. TIH and land production tubing at +/-6,975'. Return well to production as a Mesaverde/Dakota Producer.


