Procedure Description: Matador Production Company respectfully requests that the Bureau of Land Management approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC previously received eight APDs on the Uncle Ches project and has drilled four wells on the project to date. MPC believes it would be best practice to monitor the production from these wells in order to inform how MPC should continue its development of this project. As a result, a 24-month extension is requested to prudently develop the remainder of the Uncle Ches project and reduce waste. MRC is scheduled to return to drill the Uncle Ches project in Q2 2024.
