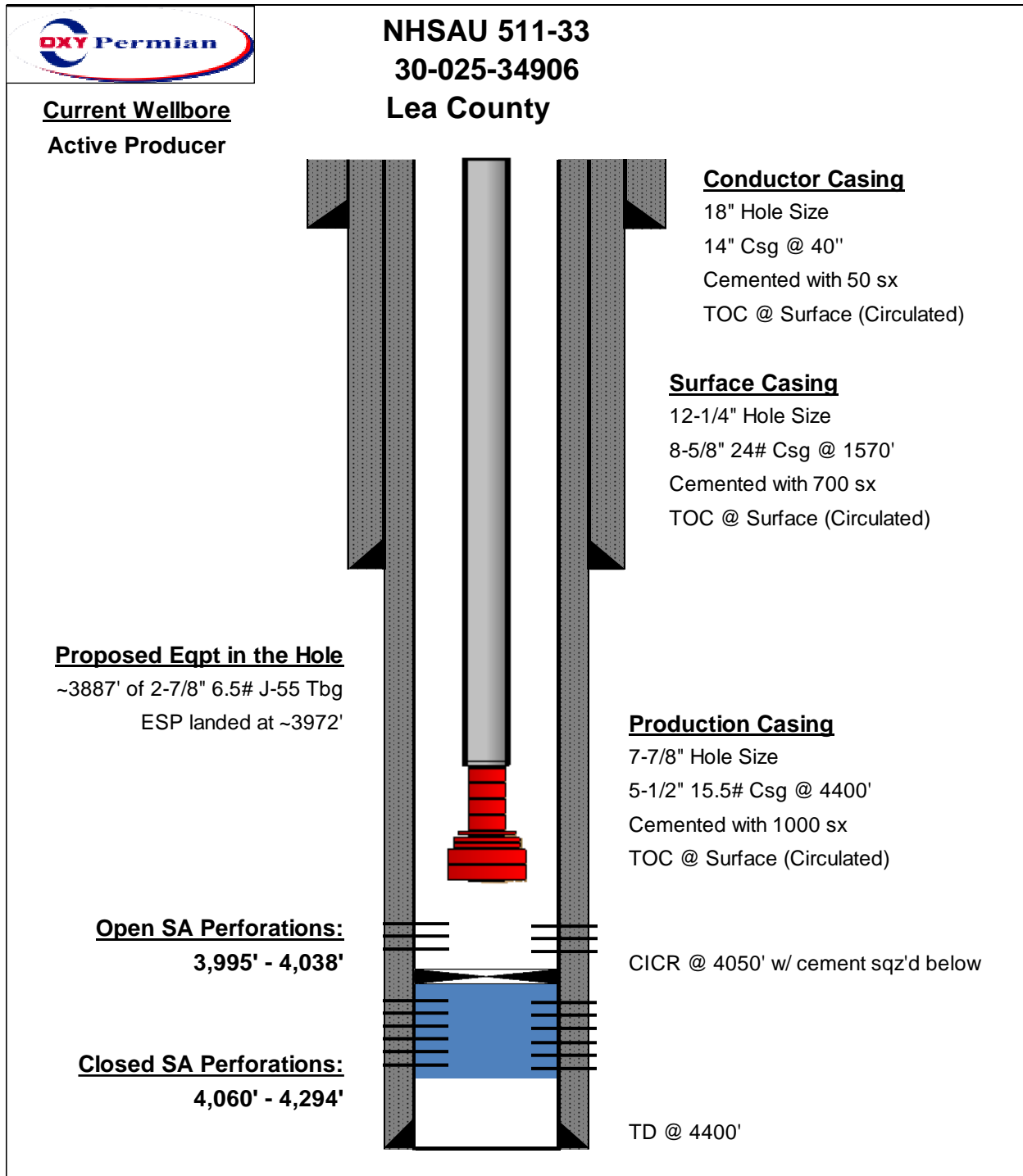

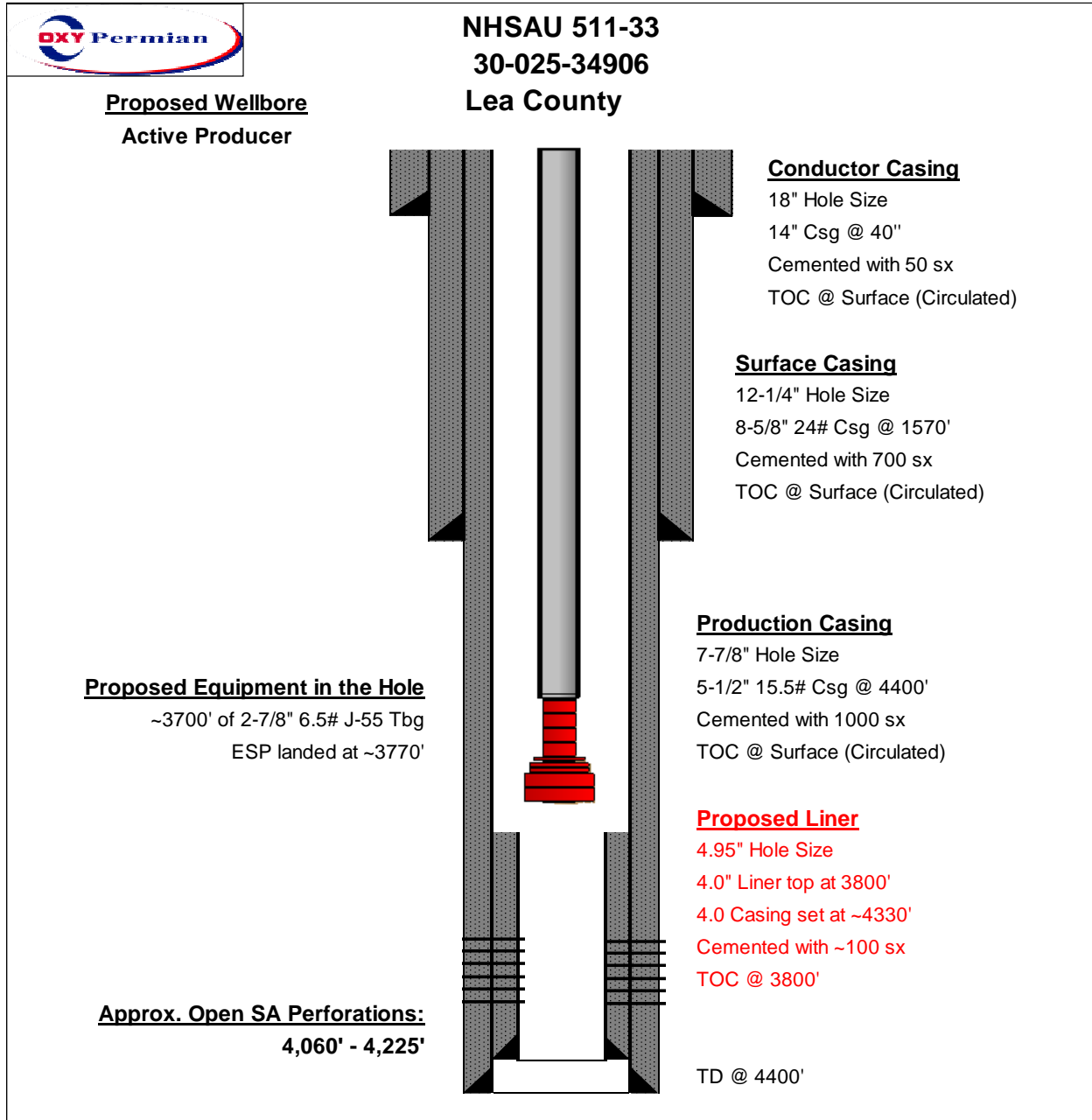

3. POOH w/ ESP eqpt
4. PU 4-3/4" bit & RIH
5. Drill out CICR & Cement to new PBTD at 4330' x Pressure test squeeze
6. POOH w/ bit
7. RIH w/ 4.0" 9.5# FJ liner. Land liner from 3800'-4330'. Cement liner in place w/ ~100 sx.
8. RIH w/ 4-3/4" bit & DO to top of liner. Pressure test liner top. POOH w/ 4-3/4" bit.
9. RIH w/ 3-1/4" bit & CO to new PBTD (Duplex Shoe at 4329')
10. RU WL x Perforate casing from ~4060'-~4225' x RD WL
11. RIH w/ 4.0" RBP & packer
12. Acid stimulate new perfs with ~3,000 gal of 15% HCL NEFE
13. POOH w/ RBP & packer
14. Run ESP Eqpt
15. RD PU
16. Return well to production
