Chevron Offline Cementing Schematic

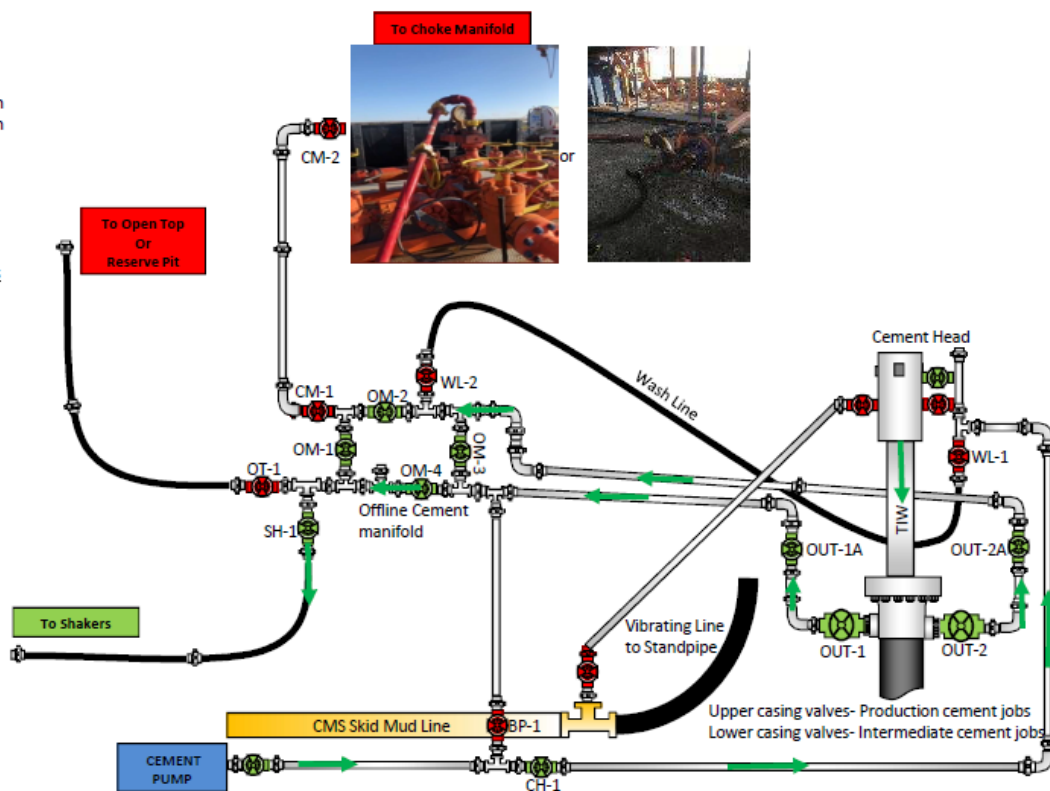
