### Chevron Offline Cementing Schematic

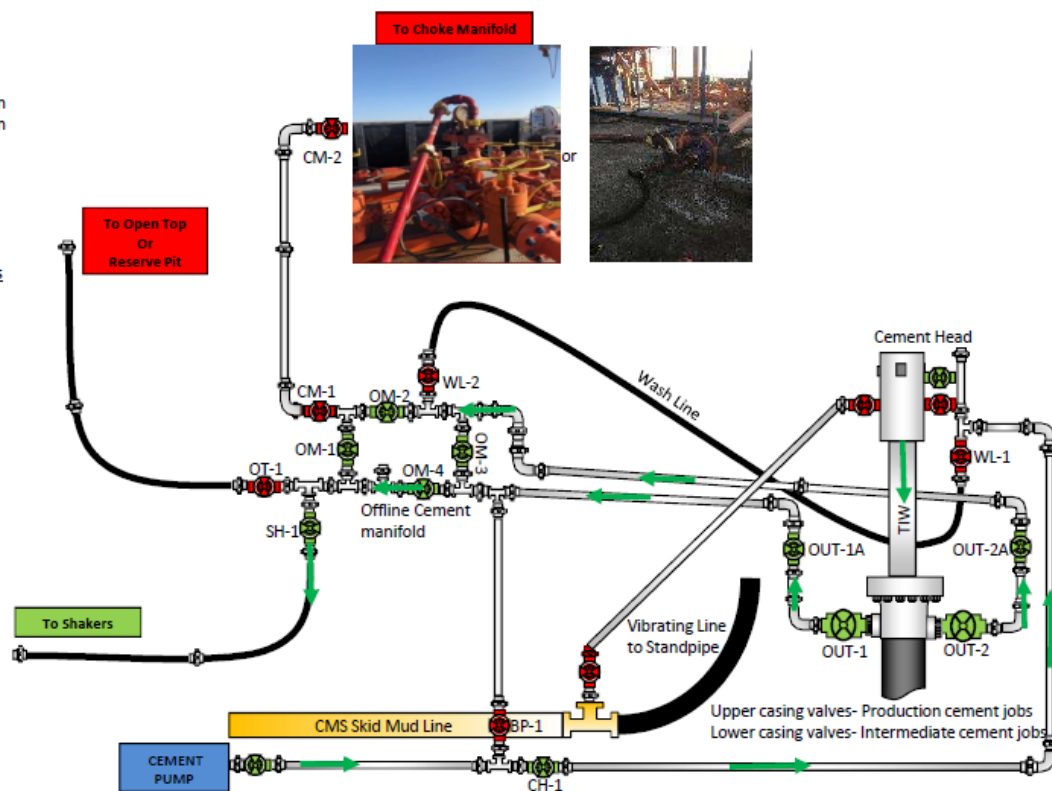
