Actual Procedure: Well spud on 5/7/2023 at 11:30 5/7/2023: Drill 14.75 inch surface hole to 1169 ft. 5/7/2023: Run 10.75 inch 45.5 lb J-55 surface casing to 1103 ft. Pump 20 bbl water spacer, followed by 500 sks of 13.5 ppg lead cmt and 390 sks of 14.8 ppg tail cmt. Drop plug and displace with 103 bbls freshwater. 126 bbls of cement returned back to surface. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 5/9/2023: Test BOPS. Drill 9.875 intermediate hole to 11937 ft. 5/16/2023: Run 7.625 inch 29.7 lb L-80 intermediate casing to 11887 ft. Pump 40 bbls spacer, followed by 1495 sks of 11.2 ppg lead cmt 295 sks of 13.2 ppg tail cmt. Drop plug and displace with 543 bbls of fresh water. 243 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 2615 for 30 minutes, good test. 5/25/2023: Drill 6.75 inch production hole to 22795 ft. 6/13/2023: Run 5.5 inch 20 lb P-110 production casing to 22776 ft MD. Pump 80 bbls spacer, then 925 sks of 14.0 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 484 bbls brine. 0 bbls cement returned to surface. Est TOC at 8000 ft.
