Tail w/200 sks Class C w/2% CaCl2 (yd @ 1.34 cuft/sk @ 14.8 PPG). Displaced w/166 bbls of BW. Plug down @ 3:00 A.M. 06/09/22. Circ 172 sks of cmt to the pit. Tested BOPE to 5000# & Annular to 3500#. At 3:15 AM. 06/10/22, tested csg to 1500# for 30 mins, held OK. FIT to 10.5 PPG EMW. Drilled out with 12 1/4" bit. 06/12/22 TD'ed 12 1/4" hole @ 4192'. Ran 4177' 9 5/8" 40# HCL80 LT&C Csg.
