

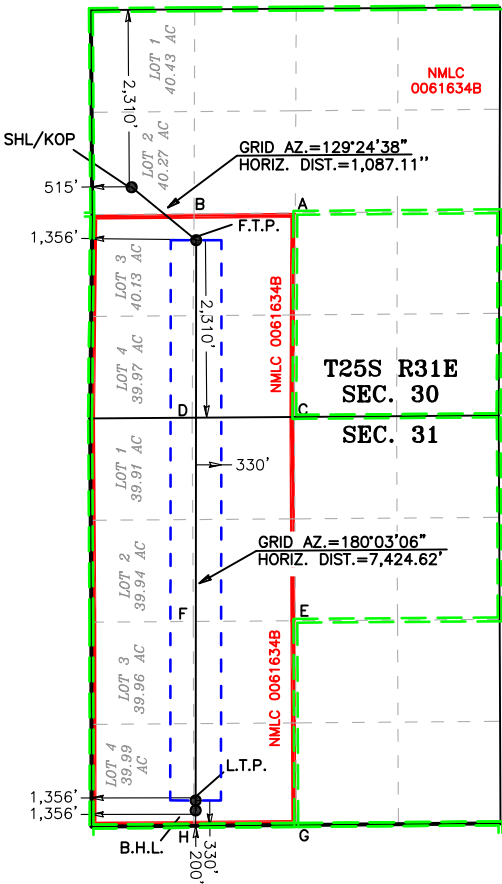
ACREAGE DEDICATION PLATS
