Spud 17 ½” surface hole @ 18:00 hours on 5/3/2025. Drill to TD @ 368’. RIH w/9 jts 13 3/8”, 54.5#, J-55 BTC surface casing set @ 368’ (casing shoe depth). M&P Type III CMT. W/ 1% CACL, 0.25 LBS/SX Cello Flake, 0.2% D-CD-2. Test lines to 1500 PSI 20 BBL FW spacer 402 SX (100 BBL) type III CMT @ 14.6 PPG, 1.38 yield, 6.65 GPS. Drop plug and displace w/ 51.6 BBL/ FW. FCP = 225 PSI @ 2.5 BBL/MIN. Bump plug w/ 650 PSI @ 10:33 on 5/4/2025. 35 BBL CMT to surface. PT will be in the next report.
