Actual Procedure: Well spud on 6/7/2023 at 18:00 6/7/2023: Drill 14.75 inch surface hole to 970 ft. 6/8/2023: Run 10.75 inch 45.5 lb J-55 surface casing to 953 ft. Pump 20 bbl water spacer, followed by 425 sks of 13.5 ppg lead cmt and 265 sks of 14.8 ppg tail cmt. Drop plug and displace with 87 bbls freshwater. 80 bbls of cement returned back to surface. EST TOC at 0 ft. Pressure test casing to 1500 PSI for 30 minutes, good test. 6/17/2023: Test BOPS. Drill 9.875 intermediate hole to 11915 ft. 6/23/2023: Run 7.625 inch 29.7 lb L-80 intermediate casing to 11915 ft. Pump 30 bbls fresh water spacer, followed by 705 sks of 10.5 ppg lead cmt 325 sks of 14.5 ppg tail cmt. Drop plug and displace with 544 bbls of fresh water. 230 bbls cement to surface. EST TOC at 0 ft. Pressure test casing to 2620 for 30 minutes, good test. 6/24/2023: Drill 6.75 inch production hole to 22785 ft. 7/8/2023: Run 5.5 inch 20 lb P-110 production casing to 22768 ft MD. Pump 80 bbls spacer, then 940 sks of 14.0 ppg tail cmt. Drop plug and displace with 20 bbls sugar water and 470 bbls brine. 0 bbls cement returned to surface. Est TOC at 8301 ft.
