Par Five cmt w/450 sks Class C w/5% Salt, 2% Extender, 3#/sk Kolseal, 5 #/sk Pumice & 0.125 #/sk Cellophane (yd @ 2.3 cuft/sk @ 12.5 PPG). Tail w/200 sks Class C w/2% CaCl2 (yd @ 1.34 cuft/sk @ 14.8 PPG). Displaced w/147 bbls of BW. Plug down @ 01:30 A.M. 07/29/23. Circ 46 sks of cmt to the pit.
