Drill 12-1/4" hole to 1600'. 08/19/2023 RIH & set 9-5/8" 36# J-55 BTC csg @ 1600', pump 30 bbl FWS, then cmt w/ 410 sxs class C w/ additives 12.8ppg 1.68 yield followed by 170 sxs class C w/ additives 14.8ppg 1.33 yield. Full returns throughout job, circ 70 sxs to surface. Test 9-5/8" csg to 1500# for 30min, good test. Drill 8-3/4" hole to 10,642'M/ 5,145'V – TD reached on 09/24/2023.
