Zota, As discussed this morning due to operational issues while drilling the riverbend pad we are requesting to forego Cement bond logs on the liner due to the following: 1. We have experienced significant delays while drilling this project with 2 lost BHA's. Due to this our Frac will be moving onto these wells and we want to avoid significant economic delays and forgo logging giving us the ability to toe prep these wells without sitting the frac crew for the most efficient economic development. 2. All three previous strings (13-3/8". 9-5/8", 7") were pumped with cement returns to surface. 3. The liner jobs on the 19H and 20H wells were pumped with full returns, the plugs bumped, and we circulated spacer off the top of the liner indicating tie in to the 7" casing. All liner top packer were successfully set and both positive and negative pressure tested with fresh water on the negative test under the hydrostatic of the well indicating that we have good hydraulic and casing integrity from the liner top to production casing.
