Drill 12-1/4" hole to 1600'. 10/17/2023 RIH & set 9-5/8" 36# J-55 BTC csg @ 1600', pump 30 bbl FWS, then cmt w/ 415 sxs class C w/ additives 12.8ppg 1.68 yield followed by 170 sxs class C w/ additives 14.8ppg 1.33 yield. Full returns throughout job, circ 143 sxs to surface. Test 9-5/8" csg to 1500# for 30min, good test. Drill 8-3/4" hole to 10,137'M/ 4,552'V – TD reached on 10/22/2023.
