Drill 12-1/4" hole to 1650'. 08/19/2023 RIH & set 9-5/8" 36# J-55 BTC csg @ 1650', pump 30 bbl FWS, then cmt w/ 410 sxs class C w/ additives 12.8ppg 1.68 yield followed by 170 sxs class C w/ additives 14.8ppg 1.33 yield. Full returns throughout job, circ 80 sxs to surface. Test 9-5/8" csg to 1500# for 30min, good test. Drill 8-3/4" hole to 10,415'M/ 4,827'V – TD reached on 10/11/2023. RIH & set 7" 32# L-80 BK-HT csg @ 5058' then crossover and set 5-1/2" 20# L-80 BK-HT csg @ 10,415', pump 20 bbl FWS, then cmt w/ 420 sxs class C w/ additives 11.4ppg 2.46 yield followed by tail job w/ 1370 sxs class C w/ additives 13.2ppg and 1.4 yield.
