Par Five cmt w/375 sks Class C w/2% Extender, CaCl2 (yd @ 1.34 cuft/sk @ 14.8 PPG). Displaced w/38 bbls of BW. Plug down @ 10:15 PM 11/10/23. Circ 187 sks of cmt to the pit. (Notified by Email but did not witness.) Tested BOPE to 5000# & Annular to 3500#. At 5:00 A.M. 11/12/23, tested csg to 1500# for 30 mins, held OK. FIT to 10.5 PPG EMW. Drilled out w/12 1/4" bit. 11/14/23 TD'ed 12 1/4" hole @ 3343'. Ran 3328' 9 5/8" 40# HCL80 LT&C csg. Held safety meeting. Pumped 20 bbls of FW spacer.
