ACREAGE DEDICATION PLATS

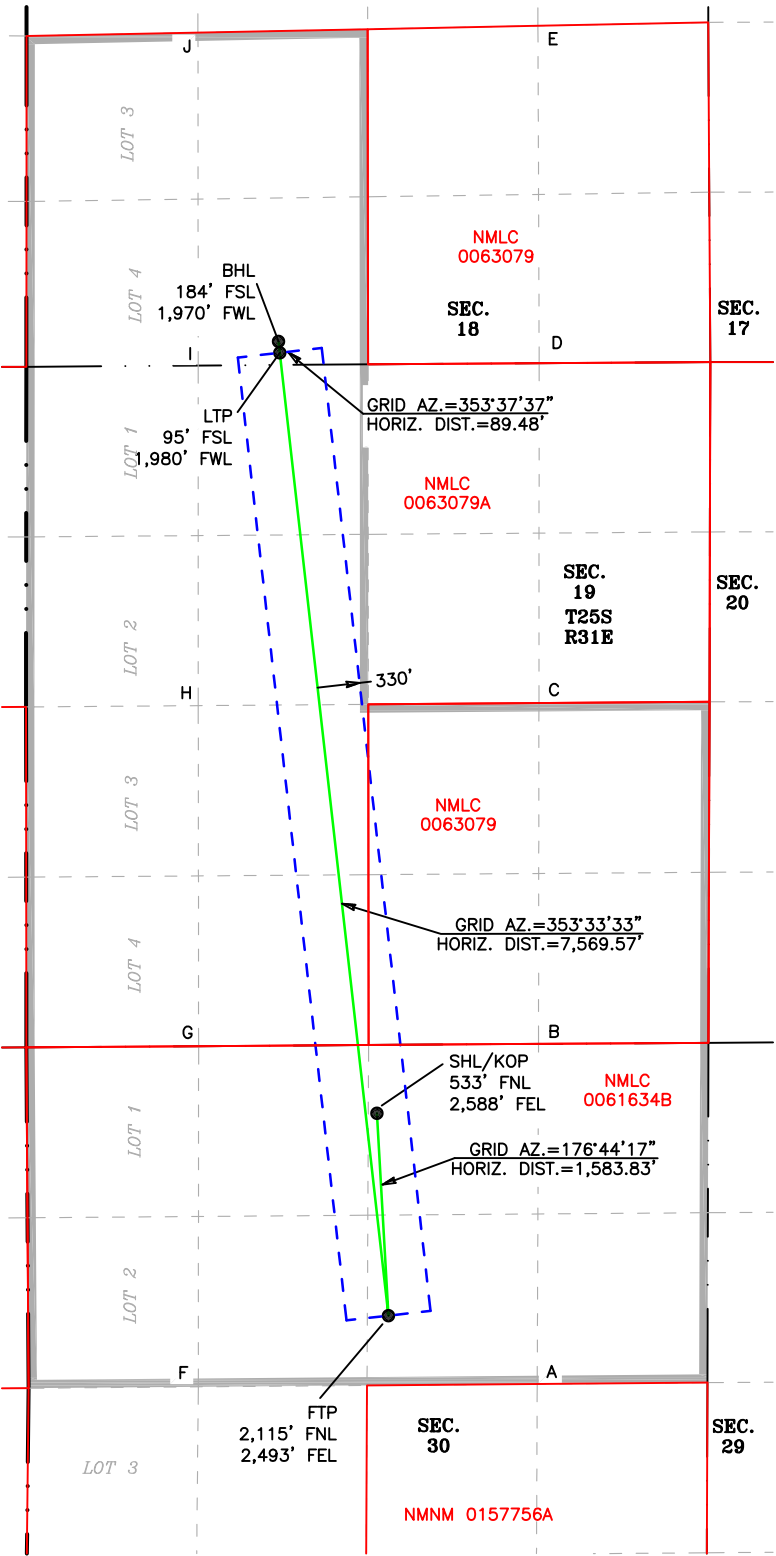
