Procedure Description: OXY USA Inc. respectfully requests special extension approval to continue drilling the subject wells over the APD expiration date. These APDs were approved 9/30/2021. Per 43 CFR 3171.14, OXY will set surface casing on all wells starting on the first well 07/26/2025 and finishing the last well 08/01/2025. All of these wells are on the same pad, Falcon_Ridge_0602. The big rig planned move-in date is 09/13/2025, starting on the Saker 6-7 Fed 1H well and will continue drilling intermediate and production strings to TD on all wells through 01/06/2026, at which point it will rig release off of the well pad. Frac start date is planned for 04/18/2026 with a turn to production estimated date of 06/13/2026.
