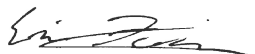

OXY USA INC requests approval to add the following wells to PLC 844F for gas production at the Federal 26 Battery (P-23-22S-31E). These wells are included in the currently approved pool of LIVINGSTON RIDGE; DELAWARE (39360) and lease NMNM 062589. Allocation will be by well test, as stipulated in PLC 844F. The C-102 forms are attached.

The wells will be added to the Federal 26 Battery (referred to as Train C1 in Exhibit C in PLC 844F). The wells will be moved from individual Train D1 (from Exhibit C in PLC 844F) to the aforementioned Train C1. Train D1 will be removed from PLC 844F. All other facilities in PLC 844F are unchanged.

Each facility/ train listed in PLC 844F will still have a sales-quality orifice meter (BLM gas FMP or equivalent meter) that continuously measures gas volume before it leaves the facility. The commingling of wells upstream of these meters is pending approval by sundry to CTB 1046, with allocation by well test. Any commingling of wells upstream of all other facility FMP gas meters or equivalent meters has been approved according to the commingle orders for each individual train/ facility and is allocated to each well based on well test

This request is for gas production downstream of the aforementioned individual battery sales quality orifice meters. Oil and gas production at the battery level will be handled through an amendment to CTB 1046.
