ALLISON 1R - CURRENT WELLBORE SCHEMATIC



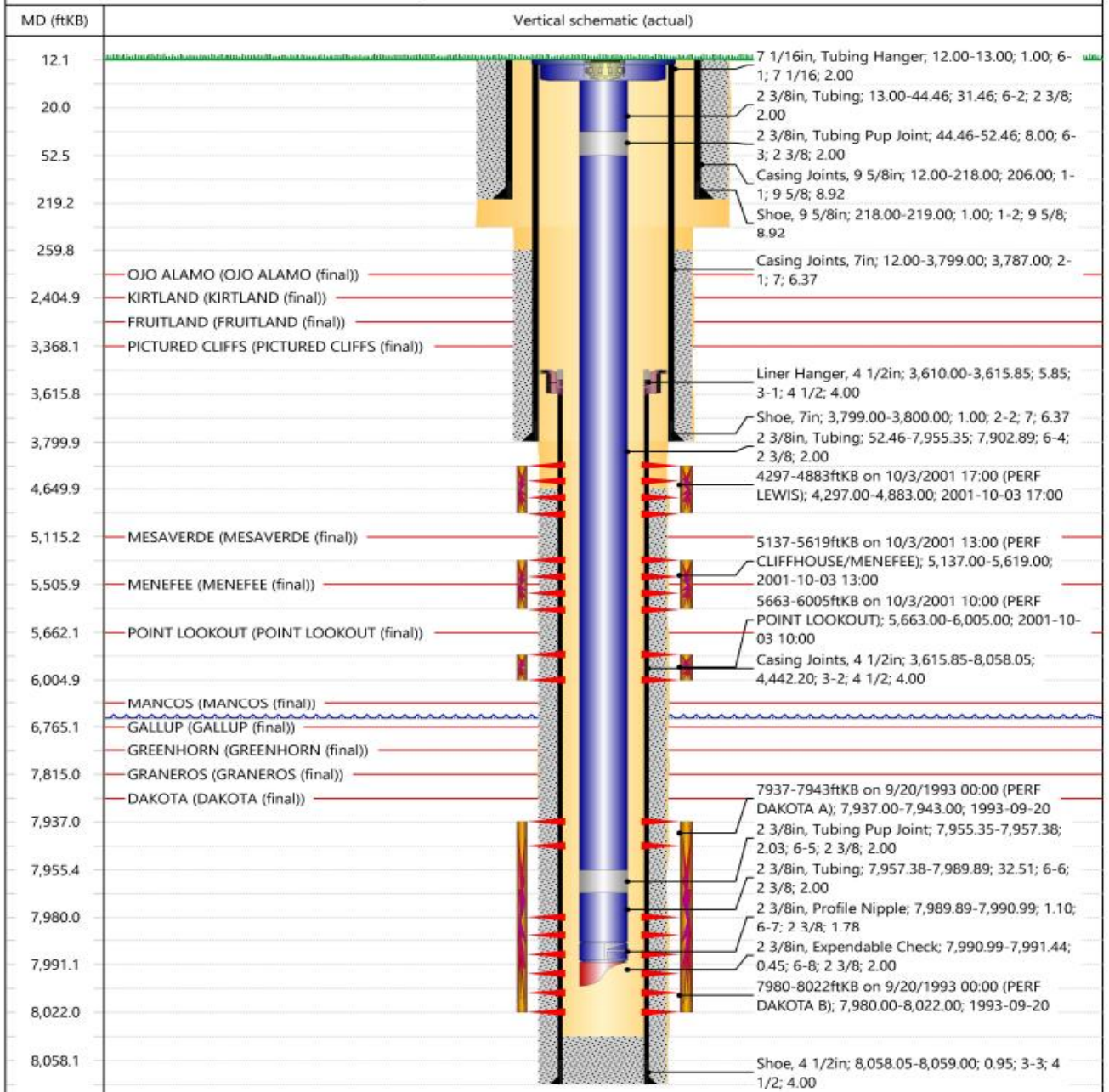

ALLISON 1R - PROPOSED WELLBORE SCHEMATIC

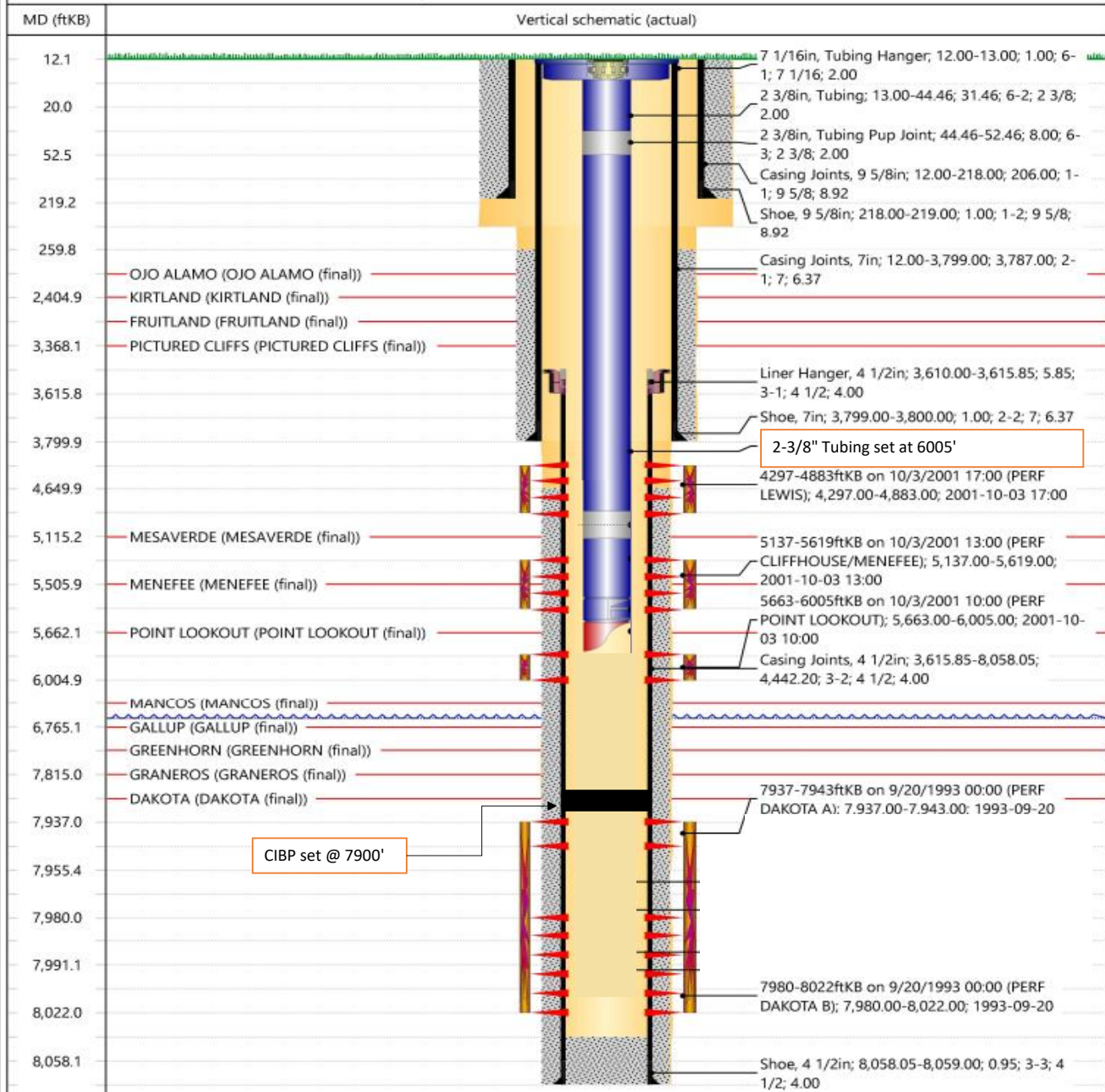
