Procedure Description: XTO Permian Operating respectfully requests a 2-Year APD extension for the following wells: Poker Lake Unit 18 TWR 110H; Poker Lake Unit 18 TWR 118H; Poker Lake Unit 18 TWR 313H; Poker Lake Unit 18 TWR 314H. These wells are located on multi-well pads designed for efficient mineral development. The additional time will allow for proper evaluation of completion data on existing wells to enable prudent oil and gas mineral development of multiple zones through reservoir delineation (stacking, spacing, and well count) to maximize production and minimize surface disturbance. Original permits expire 9/15/2025.
