These wells are located on multi-well pads designed for efficient mineral development. The additional time will allow for proper evaluation of completion data on existing wells to enable prudent oil and gas mineral development of multiple zones through reservoir delineation (stacking, spacing, and well count) to maximize production and minimize surface disturbance.
