- Pull up from packer. Circulate backside with packer fluid. Latch back in to packer.
- Contact NMOCD & run MIT test per OCD representative's directive.

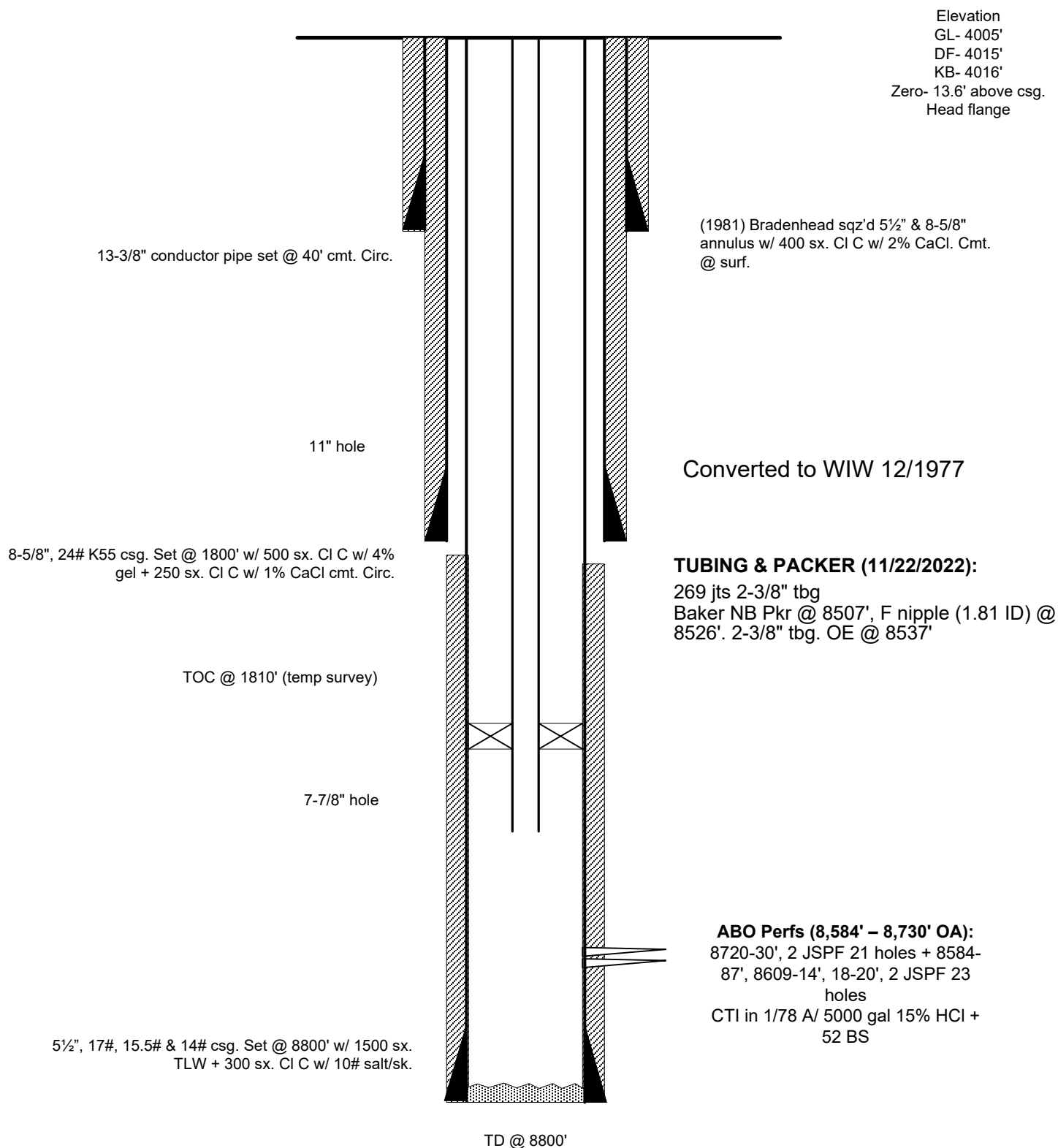
