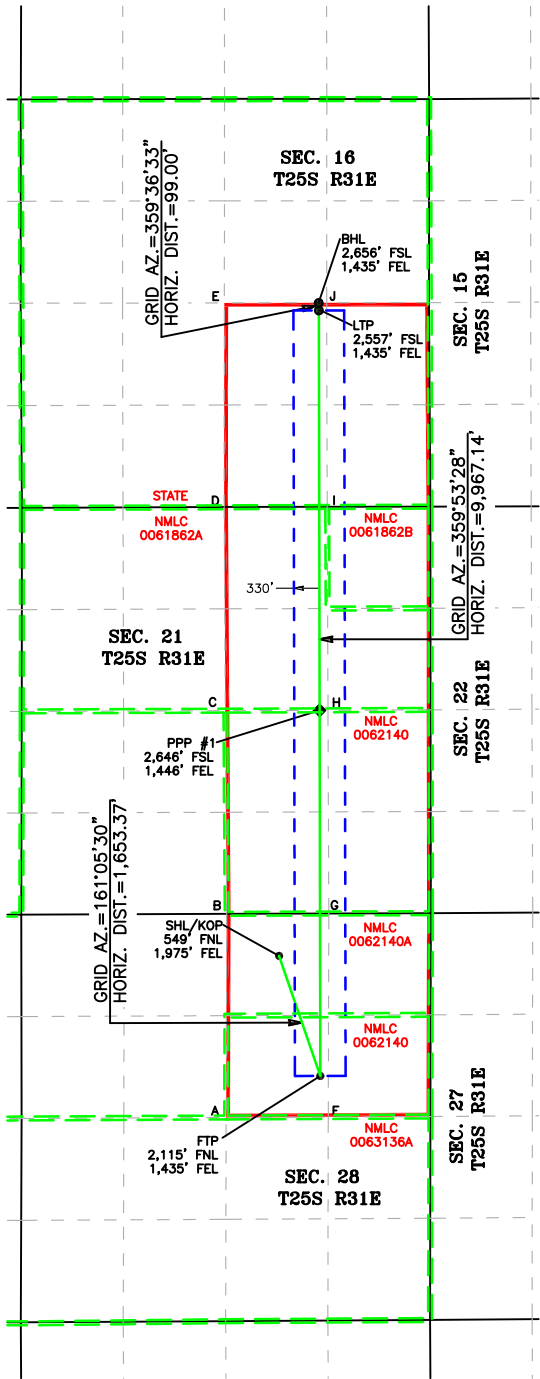
ACREAGE DEDICATION PLATS
