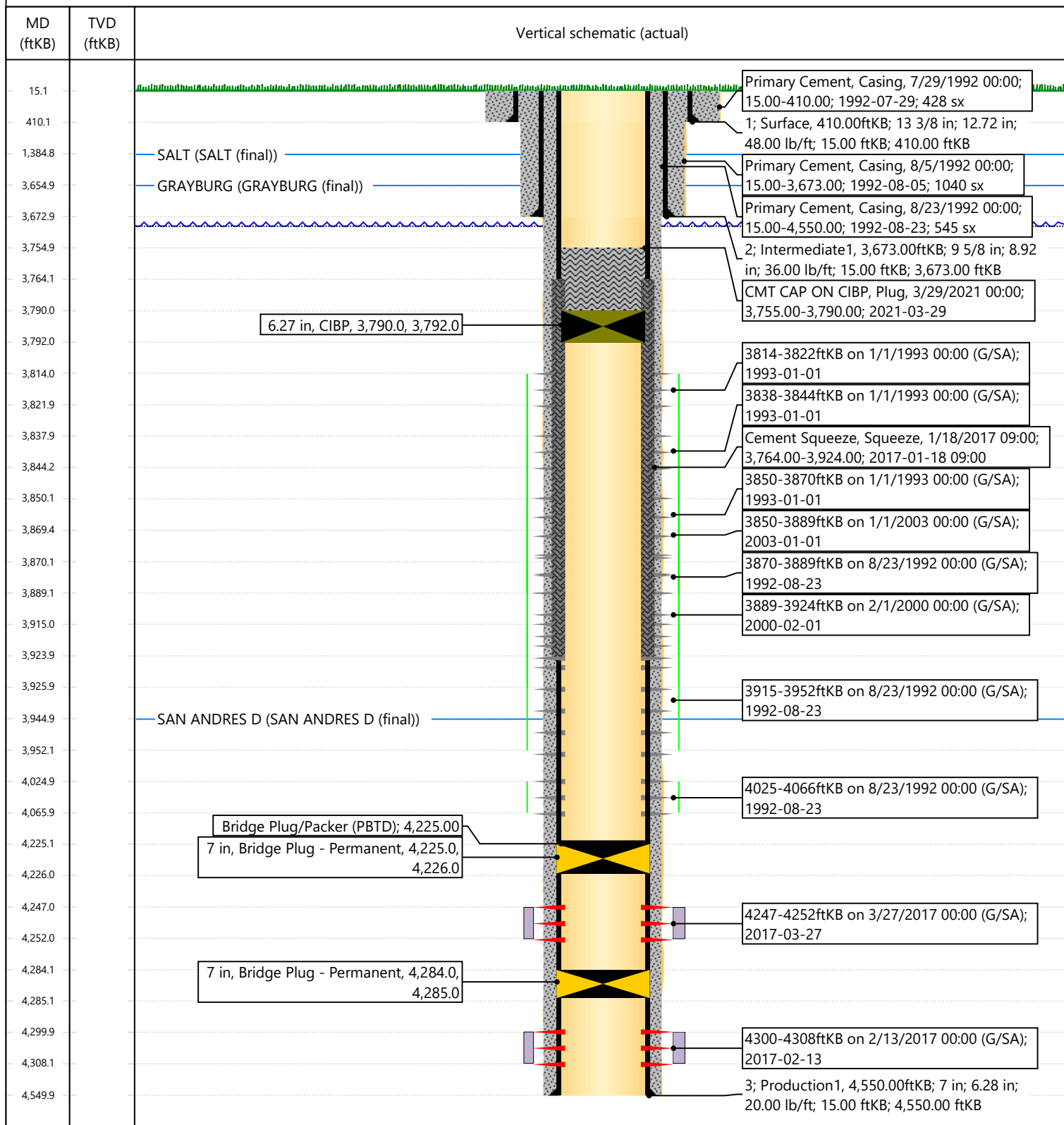

Hilcorp Energy Company recently purchased the NMGSAU asset from Apache Corporation. The above listed wells are upcoming TA expirations. After a quick evaluation, Hilcorp plans to plug and abandon 2 of the wells and is requesting a TA extension on the remaining 4. We need additional time to develop our forward plan for this asset. NMGSAU #441 is a convert to injection candidate to complete a 5-spot pattern in the SE corner of the waterflood unit. NMGSAU #013, #022, and #385 all are in the sweet spot of the flood will be submitted for reactivation in the next budget cycle. NMGSAU #015 and #354 are in the pinchouts and only contain gas reserves, thus will be submitted for P&A. Hilcorp ensures that the 4 wells will be returned to production or plugged, before the extension expires.
