Drill 12-1/4" hole to 1329'. 05/02/2025 RIH & set 9-5/8" 36# J-55 BTC csg @ 1329', pump 30bbl FWS, then cmt w/ 98 bbl (385 sxs) class C w/ additives 12.8ppg 1.41 yield followed by 41 bbl (175 sxs) class C w/ additives 14.8ppg 1.33 yield. Full returns throughout job, circ 53 bbl (212 sxs) to surface. Drill 8-3/4" hole to 10165'M/4375'V – TD reached on 05/06/2025.
