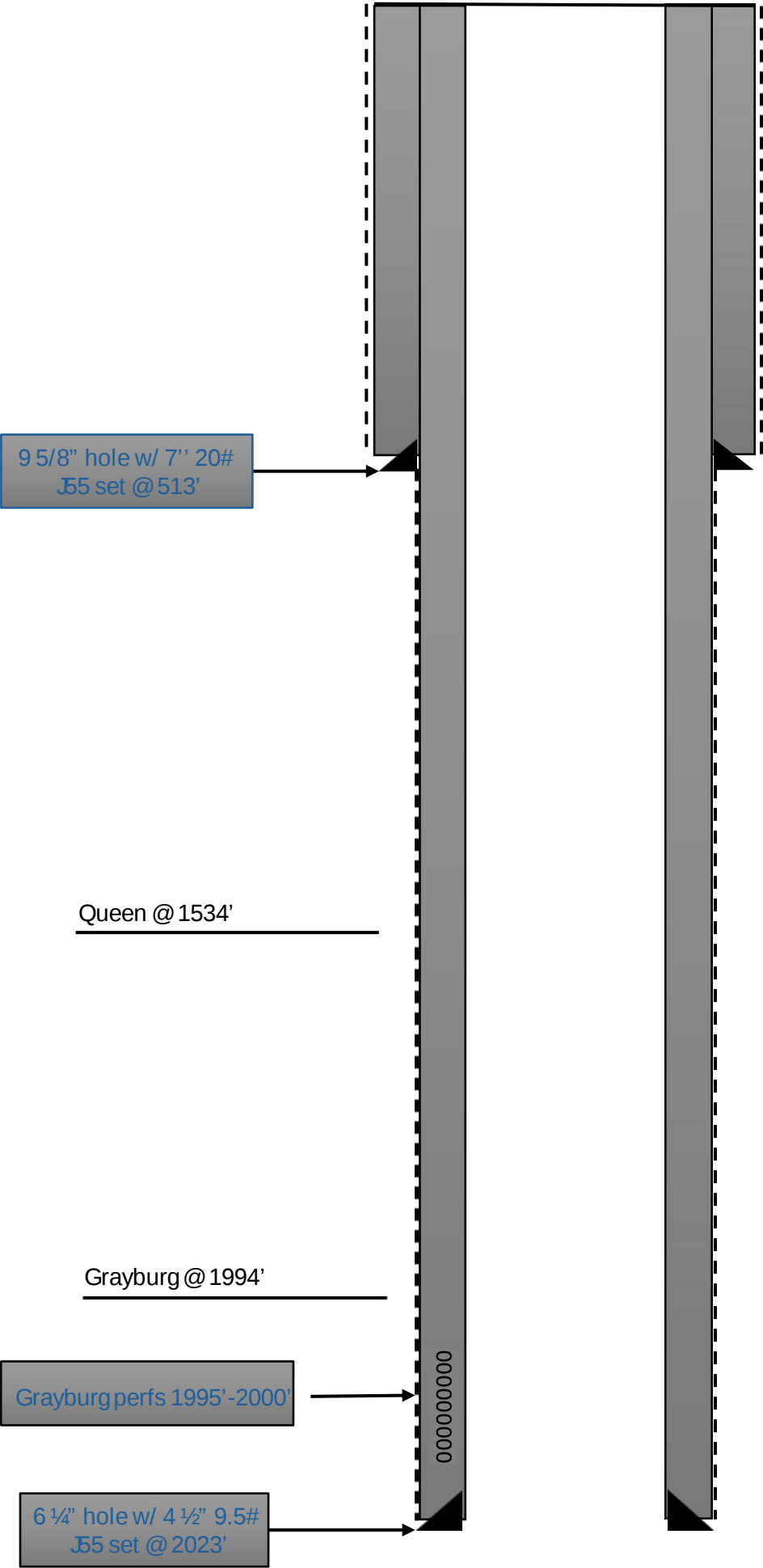

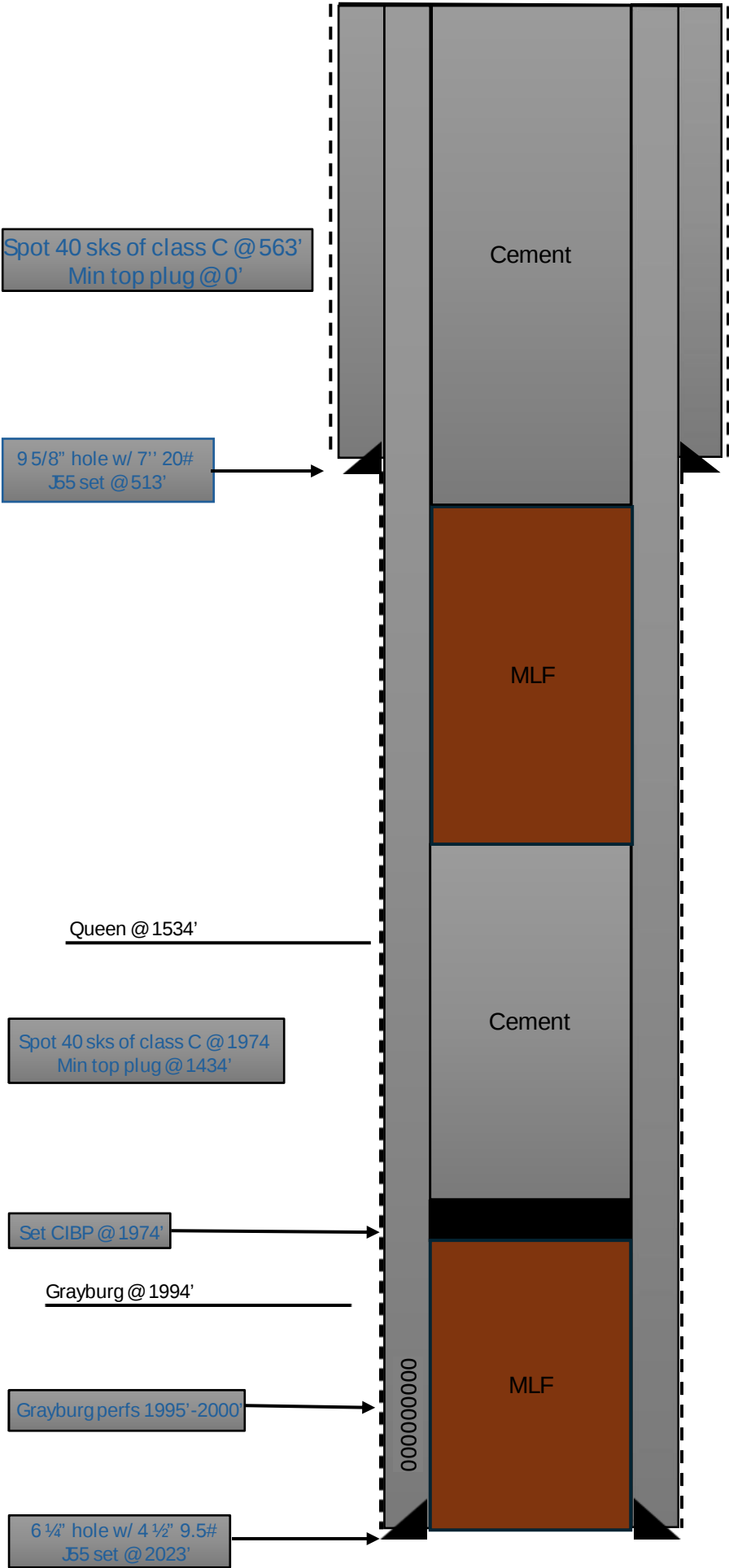
RESLER YATES STATE #332- Before WBS

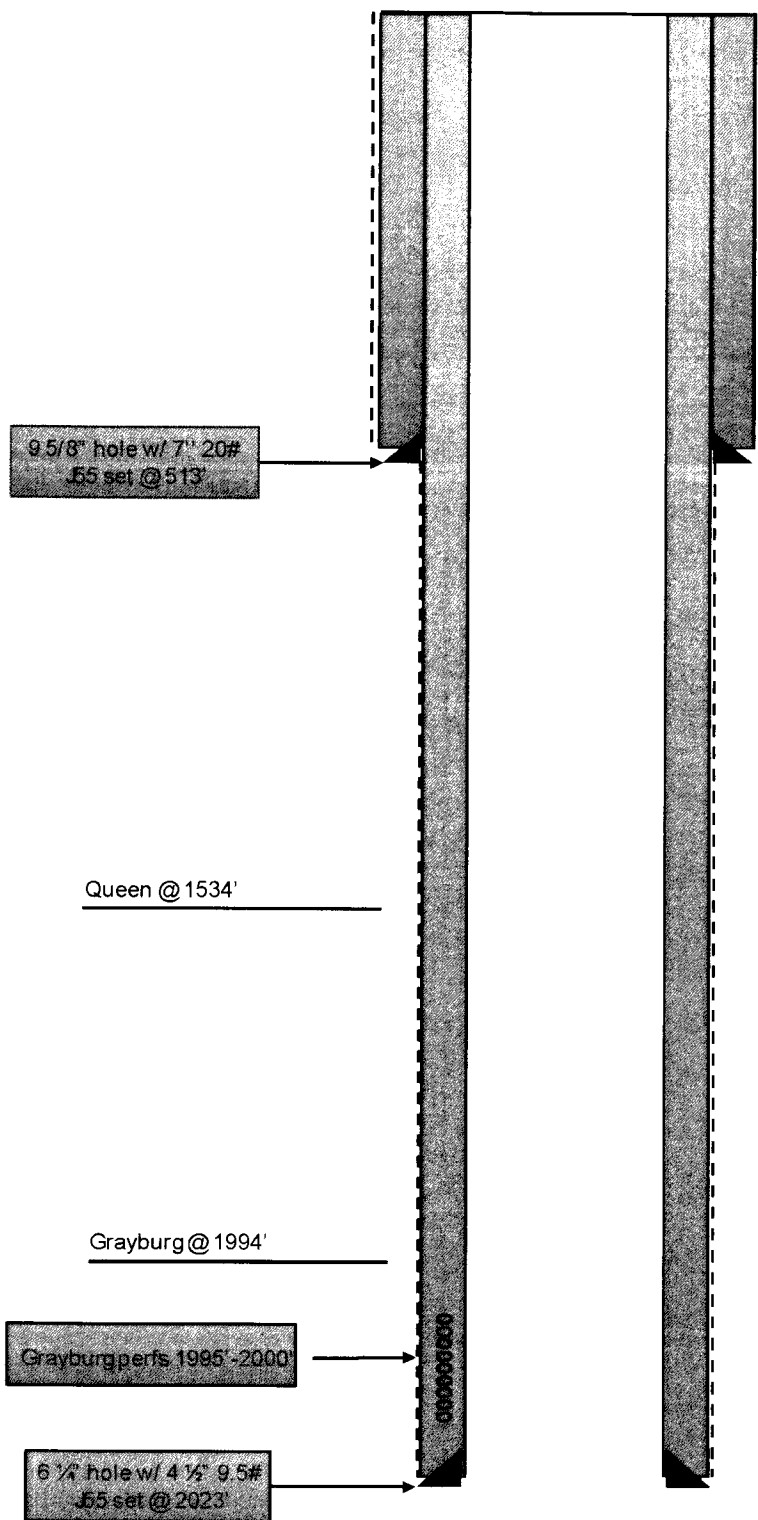

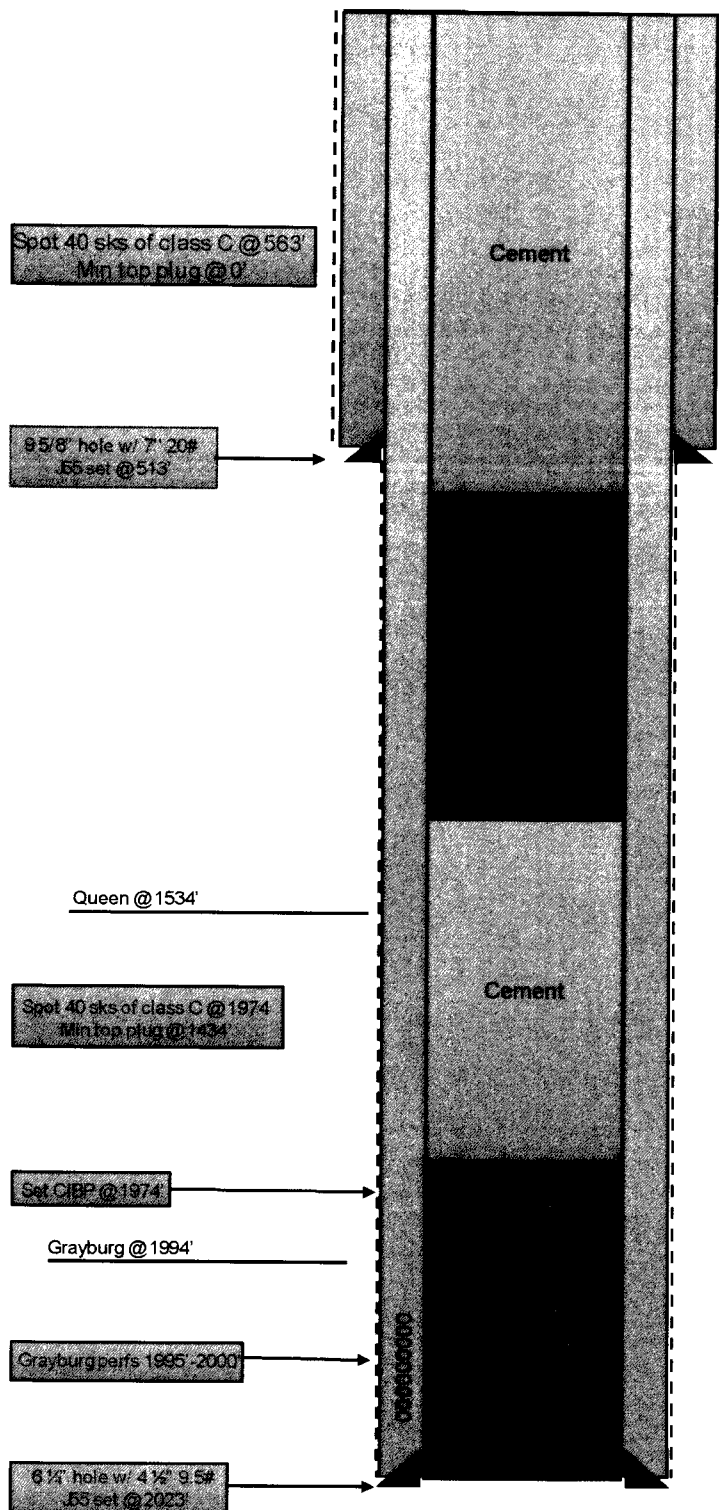
