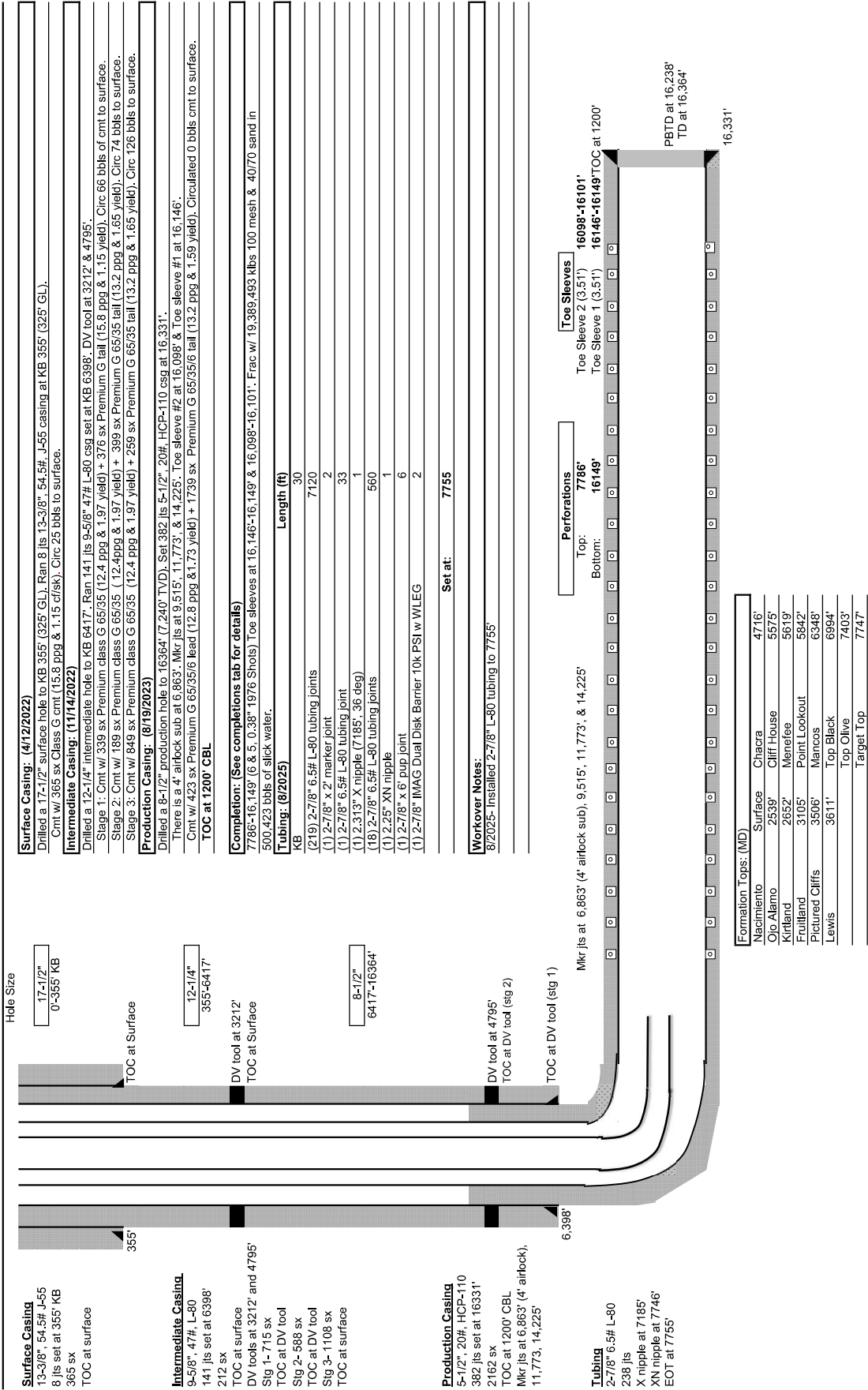


Wellbore Schematic
