**Procedure Description:** Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. The BLM approved nineteen permits in 2023 and MRC proceeded to drill eight wells on the Simon Camamile project in 2023 and 2024 as part of its initial batch. MPC believes it would be best practice to monitor the production from these well to inform how MPC should continue its development of this project. MPC’s next batch of four to six wells is scheduled for Q2 2026. As a result, a 24-month extension is requested to prudently develop the remainder of the Simon Camamile project and reduce waste.
