Procedure Description: Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC received these APD as part of its acquisition of Ameredev in 2024 has submitted sundries on at least six permits to modify the wells to fit Matador’s technical specification. MPC plans to drill six wells on this project in Q1 2026 in its initial batch. MPC believes it would be best practice to monitor the production from these well to inform how MPC should continue its development of this project. As a result, a 24-month extension is requested to prudently develop the remainder of the Dogwood project and reduce waste.
