**Procedure Description:** BLM Bond NMB001079 Surety Bond No.: RLB0015172 Matador Production Company respectfully requests that the Bureau of Land Management (“BLM”) approve the extensions of the Applications for Permits to Drill (“APD”) referenced herein. MPC received these APDs as part of its acquisition of Ameredev in 2024 and there are twelve horizontal wells currently producing on this unit. MPC believes it would be best practice to monitor the production from the upcoming adjacent wells to inform how MPC should continue its development on the Holly project. As a result, a 24-month extension is requested to prudently develop the remainder of the Holly project and reduce waste.
