Actual Procedure: 12/21/2024: Test BOPS. Drill 7.875 inch production hole to 15160ft. Run into tight hole and continued to trouble shoot. Work bit and wash and ream hole. 12/30/2024: Drill 7.875 inch production hole to 15242ft. Ream hole and continue on. Drill 7.875 inch production hole to 18089ft. Due to hole conditions deteriorating, decision was made to pull back and sidetrack, could no longer ream due to tight hole. 1/5/2025: Pulled back to 12777 ft and drill 7.875 production sidetrack hole. Drill 7.875 inch production hole to 23762 ft – TD reach on 1/12/2025. 1/14/2025:Run 5.5 inch 20 lb P-110 production casing to 23731 ft MD. Pump 40 bbls fresh water, then 310 sks of 10.5 ppg lead cmt and 2580 sks of 13.2 ppg tail cmt. Drop plug and displace with 527 bbls brine water. 130 bbls returned to surface. Est TOC at 0 ft.
