Drill 12-1/4" hole to ~1850' w/ brine mud. Run 9-5/8" 40# L80 BTC casing to TD and cement to surface in one stage.

Drill 8-3/4" hole to ~8,400' with cut brine WBM. Run 7-5/8" 29.7# P110 W513 casing to TD and cement to liner top in one stage.

Drill 6-3/4" vertical hole, curve & lateral to 18,935' with OBM. Run 5-1/2" 23# P110 BTC/W441 casing from 0' – TD and cement to 6,500' in one stage.
