

MOB in on 10/20/25. 10/21/25: Pump kill mud to kill well. ND Wellhead NU BOP. Release Packer. TOOH with injection tubing. 10/30/25: MIRU WL and run CBL. RDMO WL. CBL sent to OCD. 10/28/25: Set CIBP at 7133 feet. Spot 25 sacks of class C cement on top of CIBP per instructions from BLM rep Robert Trujillo. POOH w/ work string. Pressure tested. Good test. Tagged TOC at 6856'. Pumped 25 sacks of class C cement at 5856 feet. Pumped 30 sks of class C cement at 4800'. Pulled up to 2500' and spotted balanced plug of 25 sks of class c cement. 11/01/25: Mu to 1050 feet and perforated casing. Established circulation. Set CICR at 800' and squeezed 30 sacks behind casing and spotted 25 sacks of class c cement inside casing. 11/2/25: Shot circ holes at 100', circulated 35 sks of class c cement around 5 1/2" back up 8 5/8" annulus getting cement to surface both sides of casing. Cut off wellhead. Install P&A marker to comply with regulations. Record GPS coordinate for P&A marker on tower report. Photograph P&A marker in place. RDMO.
