Re: 3R Operating's Request to Plug and Abandon Wells

Dear Mr. Tramell:

The Oil Conservation Division ("OCD") received your email requesting permission for 3R Operating ("3R") to plug and abandon the following wells: East Red Lake Unit #002 (API 30-015-01303) and East Red Lake Unit #004 (API 30-015-10200).

Sellers & Fulton Oil, LLC is the registered operator ("Operator") of this well, and OCD consents to 3R's request to plug, abandon, and remediate the aforementioned well.

On or about November 21, 2024, a hearing was conducted regarding Operator's Notice of Violation, including Operator's violations of 19.15.25.8 NMAC. Operator was ordered to plug and abandon 36 wells, including the High Lonesome Penrose Unit No. 8 well. Order R-23566 is incorporated by reference herein as though set forth in full. Despite proper notice from OCD, Operator remained out of compliance with Order R-23566 and failed to plug and abandon the wells within 30 days. Pursuant to that Order, OCD is authorized to plug and abandon certain wells, including the East Red Lake Unit #002 and #004 wells. OCD hereby authorizes 3R to plug, abandon, and remediate the above-identified well(s) on OCD's behalf.

Please contact Michael Hall, Assistant General Counsel, at Michael.Hall@emnrd.nm.gov with questions, including the submission of plugging sundries, as OCD will not be transferring operatorship to 3R and will need to insert the plugging sundries into the wellfiles. **This letter must be submitted with the**

C-103F and C-103P filings submitted to OCD regarding the plugging of the well(s) covered by this Authorization.

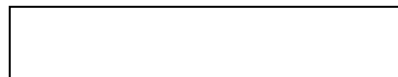
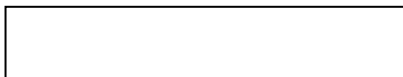
