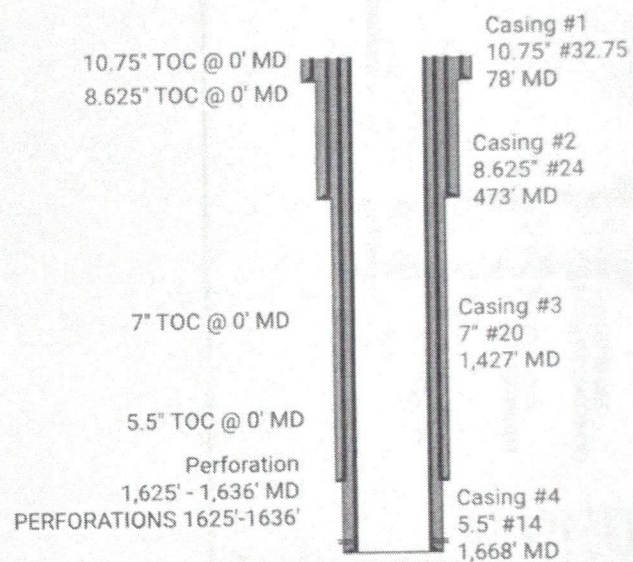

East Red Lake #001 P&A Procedure

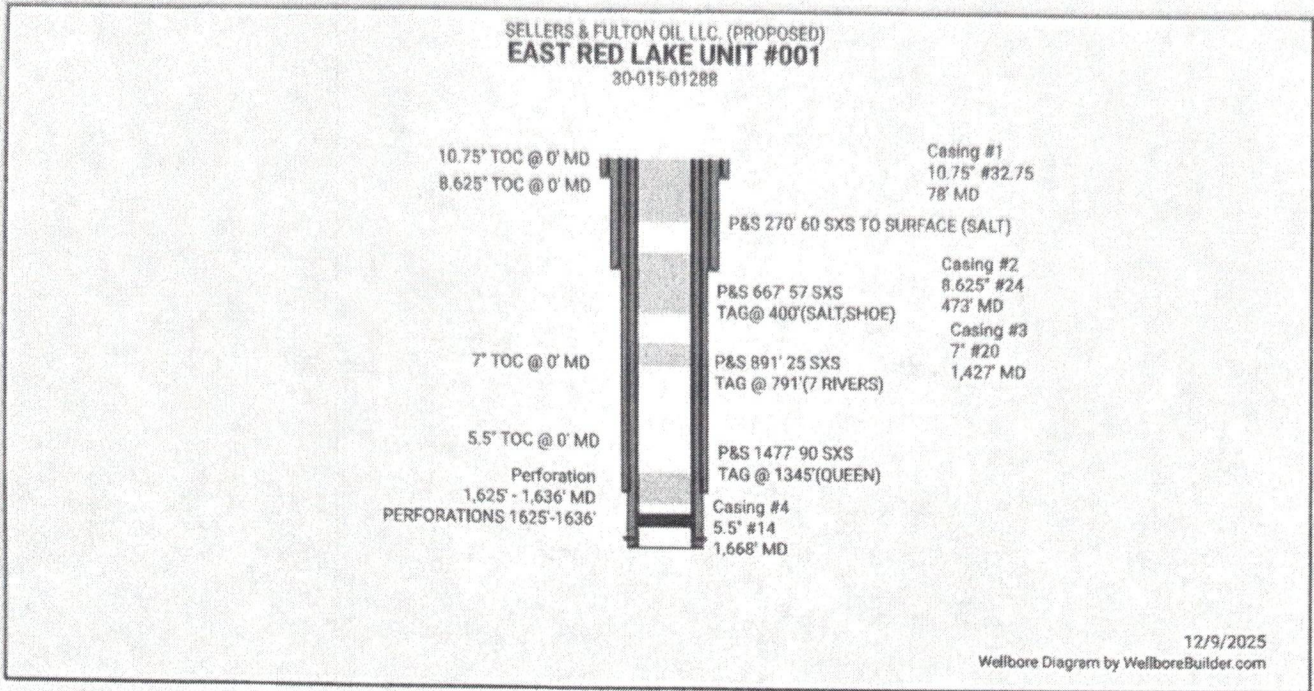
1. Notify NMOCD 24 hours prior to operations.
2. MIRU pull rods (if any).
3. NU BOP TOOH with tubing.
4. Rig up wireline RIH with GR/IB 1,575', set CIBP at 1,575'.
5. Load and roll hole pressure test to 500# for 30 minutes.
6. Run CBL 1,575' to surface.
7. Depending on CBL will determine how much cement to be placed on CBIP.
8. Perf and Squeeze @ 1,477', 90 sxs of class C cement, WOC tag at 1,345' (Queen).
9. Perf and Squeeze @ 891', 25 sxs 791' (7 Rivers).
10. Perf and Squeeze @ 667', 57 sxs 400' (Yates)
11. Perf and Squeeze @ 270', 60 sxs to surface.
12. Cut wellhead install dry hole marker.
