

Dugan Production plugged and abandoned the Herry Monster 90s from **11-20-2025 to 11-21-2025** per the following procedure:

- MI & RU Aztec Well Service Rig 481. Spot in and RU cement equipment.
- Check pressures: Tubing 0 psi, Casing 15 psi, BH 0 psi.
- Pull and LD production rods and tubing.
- PU & tally 2-3/8" work string. Run 5½" string mill to scrape casing to 1110'.
- Check pressures: Tubing 0 psi, Casing 30 psi, BH 0 psi.
- RIH & set 5½" cement retainer to 1077'. Fruitland Coal perforations @ 1127'-1149'
- Load and circulate hole clean with 30 bbls of water.
- **Pressure test casing to 650 psi for 30 minutes. Good test.**
- Run CBL from 1077' to surface. Sent copy of CBL to NMOCD. Copy of communications attached.
- Sting in retainer to establish injection rate: pressured up to 1000 psi. No injection rate.
- **Plug I, Pictured Cliffs-Fruitland-Kirtland-Ojo Alamo-Surface:** Spot Plug I inside 5½" casing above cement retainer @ 1077' to surface w/137 sks (157.55 cu ft) Class G neat cement to cover the Pictured Cliffs, Fruitland, Kirtland, Ojo Alamo tops & surface casing shoe to surface. No displacement. MI&RU welder, cut wellhead off. Tagged TOC at 0' inside and 21' annulus. **Plug I, Inside 5½" casing, cement retainer at 1077', 137 sks, 157.55 cu ft, Pictured Cliffs-Fruitland-Kirtland-Ojo Alamo-Surface, 0'-1077'.**
- Fill cellar and install dry hole marker with 20 sks, 23 cu ft, Class G neat cement.
- RD Aztec Well Service Rig 481. Clean location, move.
- Clay Yazzie with BLM witnessed the job.
- Photos of P&A marker and GPS coordinates attached per NMOCD COA.
- **Well P&A'd on 11/21/2025.**
