Procedure Description: Matador Production Company respectfully requests that the Bureau of Land Management ("BLM") approve the extensions of the Applications for Permits to Drill ("APD") referenced herein. The BLM approved nine permits in 2024 and MRC proceeded to drill eight wells on the Alyson project in 2024 as part of its initial batch. MPC believes it would be best practice to monitor the production from these well to inform how and when MPC should drill its last APD on the project. As a result, a 24-month extension is requested to prudently develop the remainder of the Alyson project and reduce waste. APD set to expire 1/26/2026.
