**Procedure Description:** Matador Production Company respectfully requests that the Bureau of Land Management ("BLM") approve the extensions of the Applications for Permits to Drill ("APD") referenced herein. MPC received these APD as part of its acquisition of Ameredev in 2024 whereas Ameredev drilled 12 wells on this project prior to transferring to MPC. MPC believes it would be best practice to monitor the production from these well to inform how it should continue its development of this project. As a result, a 24-month extension is requested to prudently develop the remainder of the Red Bud project and reduce waste. APD set to expire 1/18/2026.
