Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface.
WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.
05/29/05 Shut down due to bad weather and road conditions.
05/30/05 Drill 7 7/8" hole from 346' - 2,245'. Reached TD 2,245' at 11:30 p.m.
06/01/05 MIRU Patterson and log well. Logger's TD at 2,246'.
