Dear Mr. Smith:

Our records reflect that pursuant to Article 9 of the Horseshoe State Exploratory Unit the contraction/automatic elimination date on this unit occurred on February 7, 2012. Our review of this unit reflects the following:

- The Horseshoe State Exploratory Unit was approved effective February 7, 2007.
- Article 9 of the Horseshoe State Exploratory Unit provides for the following:
  - O Notwithstanding any of the provisions of this Agreement to the contrary, all undeveloped regular well spacing or proration unit tracts within the unit boundaries shall be automatically eliminated from this Agreement and shall no longer be a part of the unit or be further subject to the terms of this agreement unless at the expiration of five (5) years after the first day of the month following the effective date of this agreement diligent drilling operations are in progress on said tracts.
- The Horseshoe State Unit Well No. 1 (30-015-34164) (L) Sec. 33-23S-25E was determined to be a commercial Morrow well by our letter of December 19, 2007. This well is currently producing from the Horseshoe Bend; Morrow (Gas) pool (78680). The OCD spacing assigned to this well is the W/2 of Sec. 33-23S-25E, 320.00 Acres.
- No drilling operations were being conducted within the unit boundaries on February 7, 2012.

In view of the above please be advised that the Horseshoe State Exploratory unit has been automatically contracted to the NMOCD spacing unit of the Well No. 1 effective February 7, 2012. The unit boundaries now consist of the W/2 of Section 33-23S-25E.

Please also be advised that due to the automatic elimination, the following State Lease has expired by its own terms effective February 7, 2012:
