Gentlemen:

The Antebellum Unit, No. NM-68288X / Participating Area (PA) NM-68288A, Lea County, New Mexico, is terminated effective October 9, 2012, pursuant to 43 CFR 3186.1.11 and Section 11 of the Unit Agreement which state the following:

“No land shall be excluded from a participating area on account of depletion of its unitized substances, except that any participating area established under the provisions of this unit agreement shall terminate automatically whenever all completions in the formation on which the participating area is based are abandoned.”

Thus, since the Antebellum Unit #1 well (3002524523) has been plugged back to the Delaware formation (October 9, 2012) pursuant to documents filed December 11, 2012, the Morrow PA NM-68288A automatically terminated October 9, 2012. As a result of the termination of the only PA within the unit, the unit also terminates.


Pursuant to 43 CFR 3183.4(b), Public Interest requirement has been fulfilled, and the following leases NMNM0556297 and NMNM17446A are entitled to a two year extension pursuant to 43 CFR 3107.3-2 and 3107.4. This two year extension will expire October 9, 2014.

The Bureau of Land Management by their letter of January 17, 2013 has advised this office that the Morrow participating area for the Antebellum Unit Well No. 1 was automatically terminated October 9, 2012.
