Dear Mr. Bullock:

Our records reflect that the Van Dyke State Unit was approved effective September 28, 2005. The initial well, the Van Dyke State Unit Well No. 1, SW/4SE/4 Section 17-10S-33E was completed in the Cormac; San Andres pool as a non-commercial well on March 1, 2006. The Van Dyke State Unit Well No. 2 NW/4NE/4 Sec. 11-10S-33E was completed as a non-commercial well in the X-4 Ranch Atoka pool on July 20, 2007.

Article 8. DRILLING TO DISCOVERY: of the unit agreement specifies that until a discovery of a deposit of unitized substances capable of being produced in paying quantities, the unit operator shall continue drilling one well at a time allowing not more than six months between the completion of one well and the commencement of drilling operations on the next well until a well capable of production in paying quantities is completed. Since the initial and second wells are non-paying wells, the Van Dyke State Unit Well No. 3 was to have been commenced on or before January 20, 2008.

Pursuant to Article 8 of the agreement, since drilling operations were not in progress in the unit, the Van Dyke State Unit Agreement has been terminated effective January 20, 2008.
