02/19/06 Drill 7 7/8" hole from 347' - 2,675'. Reached TD 2,675' at 1:15 a.m. MIRU Patterson and log well. Logger's TD at 2,629'. Run 61 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,516'. HES mixed and pumped 393 sks Midcon II cement. Circulated 25 bbls of cement to surface.
