This is a corrected copy of Communitization Agreement NM135010 to correct the formation listed in original letter from Bone Spring to Delaware. This agreement involves 80 acres of Federal land in lease NM19423, and 40 acres of Federal land in lease NM94076, Eddy County, New Mexico, which comprise a 120-acre well spacing unit.

The agreement communitizes all rights to all producible hydrocarbons from the Delaware formation beneath sec. 23, NWSW, W/2NW, T. 25 S., R. 26 E., NMPM, Eddy County, NM, and is effective 7/12/09. Approval of this agreement does not warrant or certify that the operator, thereof, and other working interest owners hold legal or equitable title to the leases which are committed hereto.



- B. Approve the attached Communitization Agreement covering sec. 23, NWSW, W/2NW, T. 25 S., R. 26 E., NMPM, as to all producible hydrocarbons from the Delaware formation. This approval will become invalid if the public interest requirements under section 3105.2-3 (c) are not met.
- C. Certify and determine that the drilling, producing, rental, minimum royalty and royalty requirements of the Federal lease or leases committed to said agreement are hereby established, altered, changed, or revoked to conform with the terms and conditions of the agreement.
