Dear Ms. Walker:

Reference is made to your request on behalf of Burlington Resources Oil & Gas Company LP to modify the existing disposal permit by changing the maximum allowed tubing size from 4½-inch OD to 3½-inch OD. The Division finds that granting this request will not unduly increase the chances of a premature abandonment or increase the chance of improper future plugging of this well.

The administrative order is hereby amended to state disposal is authorized through "4½-inch or smaller diameter" plastic-lined tubing.

All other requirements of the above referenced administrative order and agreements in the application remain in full force and effect. The Division also reminds the Operator that the maximum surface injection pressure of 1627 psi is still a requirement of the well's operation with the smaller tubing size.

If a higher surface injection pressure becomes necessary, then the operator must conduct the proper well testing as described in the administrative order and apply for an Injection Pressure Increase order.
