04/14/06 Spud @ 7:30 a.m. Drill 11" surface hole to 326'. Run 11 jts. of 8 5/8", 24#, J55 ST & C casing at 317'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulated 3 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

04/15/06 Drill 7 7/8" hole from 326' - 2,575'. Reached TD at 2,575' at 11:00 a.m. MIRU Patterson and log well. Logger's TD at 2,578'. Run 82 jts 5 1/2", 15.5 #, J-55 LT & C casing at 2,521'. HES mixed and pumped 435 sks Midcon II cement. Circulated 28 bbls of cement to pit.
