Enclosed is an approved copy of Communitization Agreement NM138068 involving 40 acres of unleased Federal land in lease NMNM138067 and 120 acres of Federal land in lease NMNM116571, Eddy County, New Mexico, which comprise a 160 acre well spacing unit.

Please be advised that unleased lands account, NMNM138067 has been created as a PLACEHOLDER ONLY for the lease NMNM119270 and will remain in force until a decision has been made on the Class II Reinstatement that was filed on said lease on May 23, 2016. The unleased Federal land within the agreement is identified as Tract 1 of the agreement containing 40 acres.

The agreement communitizes all rights to all producible hydrocarbons from the Bone Spring formation beneath the E2E2 of sec. 21, T. 20 S., R. 29 E., NMPM, and is effective 05/01/2017. Approval of this agreement does not warrant or certify that the operator, thereof, and other working interest owners hold legal or equitable title to the leases which are committed hereto.

Approval of this agreement does not constitute an adjudication of any state, local government, or private interests, and does not constitute a warranty or certification that the information supplied by the party submitting this agreement regarding any private, state, or local government interests is accurate.

Copies of this approval letter are being distributed to the appropriate Federal agencies. You are requested to furnish all interested parties with the appropriate evidence of this approval. Determination - Approval - Certification

Pursuant to the authority vested in the Secretary of the Interior under Section 17(j) of the Mineral Leasing Act of 1920, as amended (74 Stat. 784; 30 U.S.C. 226(j)), and delegated to the authorized officer of the Bureau of Land Management, I do hereby:

- A.
