Gentlemen:

Communitization Agreement (CA) NMNM107712 was approved January 15, 2003 effective as of August 01, 2002. This agreement communitized the W2 of sec. 25, T. 21 S., R. 27 E., NMPM, Eddy County, New Mexico involving 80.00 acres of land in Federal lease NMNM14768A and 240.00 acres of land in Fee leases comprising a 320.00 acre well spacing unit as to natural gas and associated liquid hydrocarbons producible from the Morrow, Atoka, Strawn and Wolfcamp Formation.

The term of the agreement is for two years and so long thereafter as communitized substances are or can be produced from the communitized area in paying quantities.

Our records show that the last well in the above-described communitized spacing unit, Helena 25 Fee Com 1 (API# 30-015-31909) located on Fee land in the SWNW of sec. 25, T. 21 S. R. 27 E., has not produced since November of 2008. A written order (18RKC025W), dated 07/25/2018, was sent to plug or produce, with an abatement date of 08/30/2018. This date has since passed with no plans submitted.

Accordingly, in the absence of a well capable of producing communitized substances in paying quantities, CA NMNM107712 is considered to have expired effective November 30, 2008, the last day of the month during which the communitized formation actually produced. Lease NMNM14768A is eligible for a two year extension to November 29, 2010 pursuant to 43 CFR 3107.4 as a result of the termination of the subject agreement. However, lease NMNM14768A is held by allocated production from CA agreements NMNM106873 and NMNM71953.

The Authorized Officer has authority to issue a Written Order in accordance with 43 CFR 3161.2. Written Order correction and reporting time frames begin upon receipt of this Notice or 7 business days after the date it is mailed, whichever is earlier. Each stipulation must be corrected within the prescribed time from receipt of this Notice and reported to the Bureau of Land Management Office at the address shown above. If you do not comply as noted above under "Corrective Action to be Completed By", you shall be issued an Incident of Noncompliance (INC) in accordance with 43 CFR 3163.1(a). Failure to comply with the INC may result in assessments as outlined in 43 CFR 3163.1 and may also incur civil penalties (43 CFR 3163.2). All self-certified corrections must be postmarked no later than the next business day after the prescribed time frame for correction.

Section 109(d)(1) of the Federal Oil and Gas Royalty Management Act of 1982, as implemented by the applicable provisions of the operating regulations at Title 43 CFR 3163.2(f)(1), provides that any person who "knowingly or willfully" prepares, maintains, or submits false, inaccurate, or misleading reports, notices, affidavits, records, data, or other written information required by this part shall be liable for a civil penalty of up to \$25,000 per violation for each day such violation continues, not to exceed a maximum of 20 days.

Review and Appeal Rights

A person contesting a decision shall request a State Director review of the Written Order. This request must be filed within 20 working days of receipt of the Notice with the appropriate State Director (see 43 CFR 3165.3). The State Director review decision may be appealed to the Interior Board of Land Appeals, 801 North Quincy Street, Suite 300, Arlington, VA 22203 (see 43 CFR 3165.4).
