Gentlemen:

The first revision to the Consolidated Delaware Formation Participating Area "DE" is hereby approved effective as of February 1, 2012, pursuant to Section 11 of the Poker Lake Unit Agreement, Eddy County, New Mexico.

The application enlarges the Consolidated Delaware Formation Participating Area "DE" from 1,080.00 acres to 1,320.00 acres and is based upon the completion of unit well 325H, located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ (SHL) of Section 22, T.24S., R.30E., unit tract No. 43, Lease No. NMLC068431 and in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ (BHL) of Section 16, T.24S., R.30E., unit tract No. 63, state lease, with an initial potential of 667 BOPD and 520 MCFPD on February 17, 2012, from the Delaware Formation.

Copies of the approved request are being distributed to the appropriate agencies and one copy of Exhibits "A" and "B" are returned herewith. Please advise all interested parties of the approval of the first revision to the Consolidated Delaware Formation Participating Area "DE" effective as of February 1, 2012.


